- To improve knowledge and understanding of project development.
- To improve knowledge, confidence and ability in completing grant application forms and understanding the questions asked.

- Justify the need for your project with reference to evidence
- Structure and cost your project idea
- Describe how you will measure its outputs and outcomes

Understanding the Outcomes Approach

A course to help organisations take a new approach to developing their case for support and making their projects more appealing to outcomes based funders

This course will explain what outcomes are, why funders want to fund them and how organisations can improve their fundraising success by taking an outcomes approach.

Aims

- To increase organisation's ability to plan and present their projects and services based on outcomes.
- To provide organisations with the tools and knowledge to recognise the purpose and benefit of the work they do
- To increase income for organisations from funders who fund work based on outcomes

By the end of the course you will be able to:

- Understand the concept of outcomes
- Be able to identify the key outcomes in your own organisation
- Be able to develop proposals for projects and services designed to deliver outcomes
- Be able to present your proposals to funders with clear outcomes

- Understand the relevance of major donors in a fundraising strategy

Compiling a Fundraising Strategy

To consider how an effective fundraising strategy can support an organisations' growth and sustainability.

This course will guide you in how to decide the what, when, where, who and how of fundraising for your organisation.

Aims:

- To identify the key elements of a fundraising strategy
- To improve knowledge of tools which help prioritise your fundraising
- To produce a practical basic fundraising strategy which you can develop further

By the end of the course, you will able to:

- Have a basic, practical fundraising strategy for your organisation
- Be able to identify and involve the right people in developing your strategy
- Have tools to adapt your strategy in the future to changing needs
- Be able to take a longer term approach to your fundraising

Criteria

Eligibility:

All of the training courses are open to any Aylesbury Vale-based voluntary or community sector organisations. This includes registered charities, equalities groups, sport and youth groups and environmental action groups. Social enterprises and representatives from parish and town councils can also attend.

Fees:

The training programme has been subsidised by Aylesbury Vale District Council to support the voluntary and community sector and ensure as many different organisations as possible can attend. However, a small charge is required to cover the costs of training packs and administration. There will be no refund for cancellations made less than 3 working days before the event.

Fees have been set proportionately according to the size of the organisation. Fees cover all refreshments, lunch and training packs, which include hard copies of materials used throughout the course as well as a CD ROM.

Band A - £10 per delegate, per course All other voluntary and community sector organisations

Band B - £20 per delegate, per course Voluntary and community sector organisations with six or more paid staff

Band C - £50 per delegate per course Voluntary and community sector organisations based outside of Aylesbury Vale

Aylesbury Vale District Council Project Grants - Funding of up to 50% of the total project cost, to a maximum of £10,000 is available. Phone 01296 585186 or email grants@aylesburyvaledc.gov.uk, or www.aylesburyvaledc.gov.uk under *Community & Living* 'grants'.

The **Community Chest**, a partnership initiative between AVDC and the Vale of Aylesbury Housing Trust. **Micro Grants** up to £1,000 are awarded monthly, closing date 15th of each month. **Project Grants** up to £25,000 are assessed by a grants panel three times per year, the next closing date is 11th December 2009. **Long-Term Revenue Grants** of up to £25,000 per year for up to three years are due to be relaunched in April 2010, for funding from 2011-14.
